On 29/06/2018 this Court recorded the statement made on behalf of the State that they have already started mapping work in Sindhudurg District and directed the Collector, Sindhudurg, to supervise the implementation of the mapping work and take all necessary steps to complete it by 31/08/2018.

2. Today the learned AGP has submitted the report about implementation and completion of the mapping work in Sindhudurg District. The said report be taken on record. Copy of the same is supplied to the learned Counsel for the Petitioner by the learned AGP.

3. It has been informed to us by the Counsel for the Petitioner that there is no response of the State in regard to the directions contained in the paragraph Nos.4 and 5 of the said order dated 29/08/2018. Let the same be made clear by the learned AGP.
4. Having considered the prayer made in the Notice of Motion (L) No.151/17 for the present we feel it appropriate to direct the Collector Palghar, to start the mapping work, to take all necessary steps to start and complete the work in the area falling within his jurisdiction within the period of two months.
5. So far as the suggestion which have been made by learned Counsel for the Petitioner about implementation and completion of mapping work in a proper way, we direct the Petitioner to give suggestions in writing to learned AGP for taking further steps on it. We expect that the learned AGP shall inform the concerned office to examine the said suggestions and

do the needful. Let the compliance/action taken in this regard be submitted on or before the next date.

6. We also direct the State to explore possibility as to in how many Districts, the mapping work can be started immediately and simultaneously. Let this aspect be also made clear on the next date of hearing.

7. Stand over to 19/11/2018.
