**ORDER:**

This writ petition is filed seeking a Mandamus declaring the action of the respondents in not regularizing the services of the petitioner including the period of suspension from 22-8-1984 to 24-7-1992 as arbitrary and illegal.

It appears the petitioner was appointed as a contingent staff with the 3<sup>rd</sup> respondent college with effect from 2-7-1979. Thereafter, his services were ratified on 20-09-1983 by the Director of Higher Education. Thereafter, petitioner was suspended in view of certain allegations against him with effect from 22-8-1984 and though the suspension was lifted on 18-1-87, he was not permitted to join duty. However, on filing W.P.No.12479 of 1991 he was permitted to join duty on 24-7-1992. Though the petitioner is continuously working since 2-7-1979 his services are not regularized and according to the petitioner he is entitled for regularization of his services in the cadre of Class-IV employees of the 3<sup>rd</sup> respondent college while admitting the post held by the petitioner to grant-in-aid.

There is no necessity of going into all the details. It appears that during the pendency of the writ petition, the 3<sup>rd</sup> respondent already sent proposals for regularization of the services of the petitioner in the Class-IV post and further sent proposal to the 2<sup>nd</sup> respondent i.e., by proceedings dated 4-7-2001. According to the learned counsel for the petitioner the proposals sent by the correspondent of the 3<sup>rd</sup> respondent dated 4-7-2001 to the Commissioner and Director of Collegiate Education, A.P., Hyderabad have not yet been disposed of. Under those circumstances, the 2<sup>nd</sup> respondent is directed to consider and dispose of the proposals sent by the correspondent dated 4-7-2001, if not, already disposed of within a period of eight weeks from the date of receipt of a copy of this order. Further the respondents may also consider regularizing the period of suspension from 22-8-1984 to 24-7-1992. However, during the pendency of such consideration, the service of the petitioner shall not be disturbed.

With the above direction, the writ petition is disposed of. No order as to costs.
