Accordingly, the impugned orders are set aside and the respondents are directed to calculate all the dues payable to the writ petitioner, as if he retired compulsorily from service with effect from 20-11-1996, and pay the arrears and settle all other benefits arising therefrom.

Accordingly, the writ petition is allowed to the extent indicated above. No order as to costs.
