COMMON ORDER:

Learned counsel for both the parties submit that the matter has been settled out of Court amicably and the management has agreed to pay an amount of Rs.3,50,000/- towards full and final settlement of the dispute. It is also settled that the workman would be allowed to continue in the quarters allotted by the management till the end of October,2004. To this extent, the workman shall file an undertaking that he would voluntarily vacate the premises on or before 31st October,2004; otherwise, the management is at liberty to take appropriate action.

Accordingly, the writ petitions are disposed of. No costs.
