Petition under Article 226 of the constitution of India praying that in the circumstances stated in the Affidavit filed herein the High Court may be pleased to declare the action of the first respondent in not paying the petitioners their salaries, even though their posts are grant-in-aid posts, as illegal, arbitrary and violative of Art.216 of Constitution of India and the petitioners further consequentially pray that this Hon'ble Court may be pleased to direct the first respondent to release the past salaries of the petitioners from the date of their joining their respective grant-in-aid posts and pay the same to them and this Hon'ble Court may be pleased to further direct the first respondent to continue to pay the salaries to the Writ petitioners without any break or stoppage

The Court made the following

ORDER:

Aggrieved by the action of the @nd respondent in not passing orders on the proposal sent by the management for absorption of the petitioners in grant-in-aid posts as Hindi Pandit and Telugu Pandit Grade-II respectively, having given permission to the Management to fill up the vacancies by his proceedings Rc. No. 2942/B1/98, dated 04-08-1998, the present writ petition has been filed.

Heard the Government Pleader for School Education.

It is not in dispute that the respondents initially permitted the management to appoint these two petitioners to un-aided posts. While they are working in unaided posts. Vacancies have arisen in the posts that were admitted to grant-in-aid. On that the management seemed to have addressed a letter to the R.J.D., seeking permission to fill up the vacancies and the R.J.D. in his proceedings stated supra accorded permission to fill up the vacancies. Thereafter, the Correspondent by his proceedings dated 11-08-1998 having absorbed the petitioners into grant-in-aid posts submitted proposal on 21-09-1998 for approval. Since then the R.J.D. did not move in the matter and with the result, the petitioners are deprived of their salaries all these days.

In the light of the circumstances, stated above, I am inclined to dispose of the writ petition by giving a direction to the 2<sup>nd</sup> respondent to pass orders on the proposal sent by the management seeking approval of the appointments, within a period of four weeks from the date of receipt of a copy of the order, if the proposal received from the correspondent is in order. It is needless to observe that the petitioners are entitled to receive their salaries from the date on which the proposal was sent by the Correspondent i.e., from 21-09-1998.

With the above direction, the writ petition is disposed of.
