All these appeals are filed against the judgment and order passed by the learned Single Judge in Special Civil Application No.2177 of 1999 and companion matters, on 8th of October, 1999.

In the facts and circumstances of the case, and without observing anything on merits, we direct that if the appellants will make applications under Section 65 of the Bombay Land Revenue Code, 1879 (hereinafter referred to as "The Code"), the competent authority will decide the same in accordance with law and take appropriate decision thereon.
