JUDGMENT

Dayal, CJ

All these Revisions arise from the Order dated 04.12.1999 amended on 31.1.2000 by the Special Judge, P.C. Act, Gangtok holding that charges against accused No. A-11 Sriniwas Agarwal, accused No. A-13 A. B. Gurung and accused No.A-15 Sonam Wangdi Bhutia be framed under section 120-B of the Indian Penal Code and against accused No.A-1 Sri N. B. Bhandari and accused No.A-2 Sri P. K. Pradhan under section 5(2) read with Section 5 (1)(d) of the Prevention of Corruption Act, 1947 corresponding to Section 13(2) read with Section 13(1)(d) of the Prevention of Corruption Act, 1988 read with Section 120-B of the Indian Penal Code. It was further held that there was no *prima facie* material against accused Nos. A-4 to A-10, A-12, A-14 and A-17 i.e Nar Bahadur Rawat, Harka Singh Chewan, Hari Prasad Rai, R. B. Subba, Hari Prasad Sharma, S. D. Tamang, Bhim Bahadur Gurung, Chetan Das Ghimirey, Norbu Tshering Bhutia and Minzur Bhutia and so they were discharged.

Criminal Revision No.5 of 2000 has been filed by the CBI on the ground that in respect of some of the schemes there is material available on record justifying the framing of charges in those schemes but the charges were not framed in respect of those schemes. It has been submitted that Scheme Nos. 1, 10 and 11 were not even discussed. In respect of Scheme No.2, the learned trial Court held that since charge-sheet had not been filed against R. K. Goel, there was no ground to proceed with the trial against accused Nos. 1 and 2. Reason given by the learned trial Court is in fact and law no reason, since if a person had wrongly been left out, the proper course would be to proceed against that person and not to throw out the whole case. This is so in view of the legal position that the Magistrate takes cognizance under section 190 of the Code of Criminal Procedure of the offence and not of the offender and when any offender has been left out by the prosecuting branch, the



Magistrate has the jurisdiction to proceed against that person. This legal position has been clarified by the Supreme Court in M/S SWIL Ltd. Versus State of Delhi & Another 2001 AIR SCW 3017 and also in Rajendra Prasad Versus Bashir 2001 SOL Case No.554.

Learned Counsel for the parties agree that the charges framed by 3 the learned trial Court pursuant to the impugned order are not proper in form. All the Counsel agree that the matter may be remitted to the learned trial Court for considering the matter again after giving opportunity of being heard to them.

Accepting the request of the learned Counsel for the parties present, I allow the aforesaid revisions, set aside the impugned order dated 04.12.1999 amended on 31.01.2000 and the charges framed pursuant thereto and remit the matter for reconsideration after giving opportunity of being heard to all the parties concerned. Parties shall appear before the learned trial Court on 18.10.2001.
