	<p><u>28.11.2001</u></p> <p>Shri Manoj Paranjape for the petitioner.</p> <p>The matter relates to inviting tender for construction of certain building of Indira Gandhi Krishi Vishwa Vidyalaya, Raipur. Today is said to be the last date for submission of tender papers. Tender papers have not been issued to the writ petitioner without assigning any reason. The petitioner asserts that he has a right to submit the tender papers and to compete along-with others. According to the writ petitioner he is an eligible person to compete. Shri Gautam Bhaduri appearing for the respondent-state submits that may be prima facie the petitioner is not able to fulfill the condition/criteria expected of a competitor. Shri Paranjape submits that if ultimately the writ petitioner is unable to fulfill the tender conditions it is for the competent authority to decide accordingly but he should be permitted to submit his tender papers. According to him the criteria laid-down by the competent authority ^{are} fulfilled by the writ petitioner.</p> <p>In my view no prejudice will be caused to anyone if I direct that the petitioner be given necessary tender papers so as to enable him to submit them and ultimately it is for the competent authority to examine such tender papers on merit and take necessary action in this regard.</p>
