Heard Shri L.C.Das, learned dounsel for the petitioner.

The writ petitioner was given appointment on 07.04.1999 as Shiksha Karmi Grade I in the subject of Chemistry at Govt. Girls Higher Secondary School, Pithora Subsequently, on 25.10.1999, another order was issued by the Collector. The operative part of the said order states that the petitioner shall be allowed to continue until the new selection is made and the process of selection should be completed within 15 days. Unfortunately, no fresh selection has been made till date. However, while the petitioner was still serving as Shiksha Karmi Grade I in the subject of Chemistry at the aforesaid school, the impugned order dated 08.10.2001 was issued by which the service of the writ petitioner was terminated. It may be stated that the said impugned order of termination was issued consequent to the order passed by the Collector on 25.10.1999. On careful perusal of the relevant documents placed on record, it is clear that the Collector's order simply stated that fresh selection should be made within 15 days and that until the next selection the petitioner should be allowed to continue. If it is correct that no fresh selection has been made till date, no order of termination could have been issued and that too
