

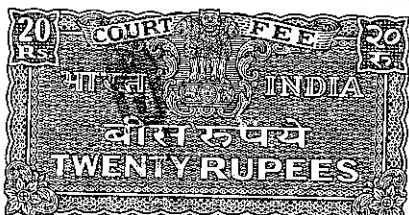

The order of appointment issued in respect of respondent no.6 on 14/7/2000 by respondents nos. 4 & 5 has been impugned in this petition. It is now stated by learned counsel for the petitioner that the said order of appointment has not been accepted by the Competent Authority i.e., the Officer Incharge of the M.P.Gramin Vidyut Sahakari Samiti Maryadit, Ambikapur District Sarguja. It is further stated that the Officer Incharge had not accepted the order of appointment of respondent no.6 i.e., Competent Authority in the matter. If that be so, in my view no issue survives consideration by the Court, inasmuch as order of appointment issued on 14/7/2000 has not been accepted. <i>Other words</i> In the order it was the fact that the order of appointment issued on 14/7/2000 has not been accepted by the Competent Authority, means that the order of appointment issued on 14/7/2000 has been undone.
