

| | <p><u>24/2/2001</u></p> <p>Heard Mr. Vishnu Koshtha, learned counsel for the petitioner.</p> <p>The petitioner while serving at Ambikapur Head Quarter, was reposted at Bilaspur Head Quarter w.e.f. 1/2/2001 and he was directed to operate Bilaspur, Ambikapur, Raigarh, Korba, Chapa, Jaspurnagar etc.,. That order was issued by the Supervisor (Sales), Raipur on 6/1/2001. Subsequently, another order was issued on 3/2/2001 by the Branch Manager directing the writ petitioner to report immediately at Ambikapur and work according to the instructions of Mr. Praveen Sethi, since Mr. Ajay Singh is not authorised to issue such transfer orders. The order further states "This supercedes the transfer advice of Mr. Ajay Singh and you are hereby advised to report at Ambikapur immediately on receipt of this letter and report directly to Mr. Praveen Sethi".</p> <p>Learned counsel for the petitioner submits that if the writ petitioner is shifted from Bilaspur to Ambikapur, it will be difficult for him to operate Bilaspur, Ambikapur, Raigarh, Korba, Chapa, and Jaspurnagar etc., as indicated in the earlier order dated 6/1/2001.
