The Court made the following:

### **ORDER:**

The writ petition is filed seeking declaration that the proceedings dated 22.2.2001 issued by the first respondent directing the Mandal Revenue Officer to conduct reelection for the School committee of Z.P. High School, Tatiparthi village, cancelling the elections conducted on 09.12.2000, as illegal, arbitrary, and contrary to the provisions of the A.P. School Education (Community Participation) Act, 1998 (for brevity, 'the Act'). This Court while admitting the writ petition on 08.03.2001 passed interim orders suspending the Proceedings issued by the first respondent to conduct re-elections to the school committee. As per Section 5 (4) of the Act, the term of elected school committee is two years and in that view of the matter, nothing survives in this writ petition.

The writ petition is therefore dismissed as infructuous.
