Diwakar, Advocate with Shri Sandeep Yadav for the petitioners.</p> <p>Shri Ranbir Singh, GA for the respondents/State.</p> <p>Having heard learned counsel, the Court is not inclined to entertain this writ petition as in its opinion the subject matter of dispute needs to be adjudicated upon by the common law forum.</p> <p>It is contended that as the petitioners had purchased some land from respondent no.1 for valuable consideration, the authorities are not justified in interfering with the possession in the garb of pendency of the ceiling proceedings. Admittedly, the said proceedings are pending against the respondent no.1 and the petitioners had purchased the land without obtaining permission from the Competent Authority.
