Baghel, counsel for the respondents No.1 &amp; 2.</p> <p>The grievance of the petitioner is to the inaction on the part of the respondents- bank in not taking decision on his representations / objections regarding his placement in the gradation list.</p> <p>According to the petitioner in the gradation list dated 16-5-2001, he was shown at Serial No. 36 whereas in the subsequent list he has been shown at Serial No.43. Aggrieved therewith he had submitted representation / objection, copy whereof is Annexure P-10 to the writ petition. Since no decision has been taken thereof he approached this Court for relief.</p> <p>In view of the limited grievance raised and prayer made by the petitioner for a direction for disposal of his representation, the Court is of the opinion that no useful purpose would be served in keeping the writ petition pending, as it can be disposed of at <sup>the</sup> admission stage by directing the respondents No. 1 &amp; 2 to take appropriate decision on the representation - objection dated 17-11-2001 filed by the petitioner within a period of eight weeks from the date of communication / receipt of the order. Ordered accordingly.</p>
