The remedy of the petitioner is to file an election petition and not the writ petition.</p> <p>In the circumstances this writ petition is disposed of with liberty to file the election petition challenging the result of the election. If the election petition is filed by the petitioner the same would be disposed of by the Registrar Co-operative Societies, as expeditiously as possible preferable within three months from the date of the filing of the petition.</p> <p><del>The petition is disposed of.</del></p>
