	<p><u>30-09-2002</u></p> <p>Shri Manoj Paranjpe, counsel for the Petitioner. Shri Ranbir Singh, Government Advocate for the State. Heard on admission.</p> <p>By this writ petition filed under Article 226/227 of the Constitution of India, petitioner prays for a direction commanding respondents to release the unpaid salary and allowances of the petitioner.</p> <p>The grievance of the petitioner is that though he was posted at Dantewada in the Office of Chief Medical and Health Officer and is working there since 01.10.2001, but his salary and allowances have not been paid for the last 10 months. The petitioner has submitted his representations vide Annexures P-4, P-5 and P-6, but no action has been taken by respondents no.2 to 4.</p> <p>Having considered the facts and circumstances of the case and material on record, it is just and proper that respondents no.2 to 4 shall decide the representations filed by the petitioner within a month from the date of receipt/production of a copy of this order and the State is obliged to ensure that the persons posted in Naxalite affected districts like Dantewada must get pay and allowances including all dues within time.</p>
