Shri Sanjay Kumar Agramai, counsel for the petitioner. State by Shri Ranbir Singh, Govt. Advocate. Kor khe By this writ petition filed under Article 226/227 of the Constitution of India, petitioner prays for a direction to the respondent no.2/the Collector to decide the application moved by the petitioner in pursuance of the order dated 12-4-1996 passed by the High Court of Madhya Pradesh, Japalpur in W.P.No.1396/1995.

The petitioner earlier filed a writ petition before the High <sup>C</sup>ourt of Madhya Pradesh challenging the caste of respondent No.3 who obtained the service in Bank under the category of SC/ST. The High Court of M.P. by order dated 2-4-1996 dismissed the petition directing as under:

> "Petitioner is challenging the appointment of respondent No.3 who is said to be not belonging to Scheduled Tribe. He may file complaint before the Collector who may take appropriate steps in the matter."

Counsel for the petitioner submits that thereafter the petitioner submitted representations dated 09-8-1996 (Annex.P-4 and another representation dated 04-9-1999 (Annexure P-5) before the Collector, but so far no action has been taken. Having considered the facts and circumstances of the case
