General for the State.</p> <p>Heard on I.A.No.7117/2002 for release of security deposit and withdrawal of petition.</p> <p>The record indicates that while giving his bid the petitioner had made a deposit of Rs.15,000/- as a security but his tender was not accepted and security amount was also not refunded.</p> <p>The main prayer in this writ petition is for cancellation of proceedings of not opening the tender. However, learned counsel states that the petitioner due to the subsequent event is not interested in proceeding with this writ petition and would like to withdraw the same and that the amount of security be refunded to him.</p> <p>Accordingly, this writ petition stands disposed of as withdrawn and since the petitioner's tender was not accepted in all fairness the amount of security i.e. Rs.15,000/- may be refunded to the petitioner in accordance with the tender conditions at an early date preferably within a period of four weeks from today.</p> <p>Consequently I.A.
