Advocate for the State/respondents.</p> <p>The main grievance of the petitioner in this writ petition under Article 226/227 of the Constitution of India is that an enquiry was instituted against the petitioner in the year 1993, the petitioner was suspended during the enquiry and the suspension order was also revoked after 45 days. Ultimately, respondent No.3 imposed penalty of withholding two annual increments with cumulative effect against which the petitioner filed an appeal before respondent No.2, the Commissioner (Revenue), and the Commissioner (Revenue) vide his order dated 16th June, 2000, partly allowed the appeal of the petitioner and the stoppage of two annual increments was made without cumulative effect instead of cumulative effect against which the petitioner has filed an appeal before respondent No.1. That appeal is pending since 02.01.2001.</p> <p>The learned counsel for the petitioner submits that by this petition he is only seeking relief that respondent No.1 be directed to dispose of the appeal of the petitioner as early as possible.</p> <p>Having heard the learned counsel for the parties and having regard to the facts and circumstances of the case, as the appeal of the petitioner is pending before respondent No.1 since 02.01.2001 i.e. since more than two years and eight months.
