But ignoring the said notification, his case has not been considered. Since the representation is admittedly pending, this writ petition is disposed of by directing the said respondent No.3 or any such other competent authority to consider the petitioner's representation and take an appropriate decision thereon on its own merits, within a period of four weeks from the date of communication/ receipt of this order. It is made clear that this Court is not expressing any opinion on the merits of the petitioner's case and that representation will have to be decided by the concerned authority on its own merits.

Consequently M.W.P. No.564/2002 for interim relief & I.A. No.4467/2002 for urgent hearing also stand disposed of.
