Though this writ petition is listed for admission, in view of the limited nature of the prayer made, which is for a direction to the authorities to consider his representation against his transfer contained in Annexure P-5, no useful purpose would be served in keeping this writ petition pending, accordingly on the prayer of the learned counsel for the parties it is being disposed of at this stage.

The challenge in this writ petition is to the order-dated 11.03.2003 (Annexure P-1) whereby the petitioner who is working as Chowkidar in MMSS/EM School, Bilaspur (of the railways) has been transferred to Shahdol (M.P.). According to the petitioner, since the order of transfer is motivated because of the annoyance of the Principal of the school it is liable to be quashed. However, these are contentions which under the facts and circumstances the Court is not inclined to go into at this stage in view of the prayer of the petitioner that his representation may be directed to be disposed of.
