Shri Ranbir Singh learned GA takes notice for respondents.</p> <p>Heard both the counsel.</p> <p>The petitioner has preferred this petition under Articles 226/227 of the Constitution of India seeking a direction to the respondents for providing the compassionate appointment to the petitioner.</p> <p>Case of the petitioner in brief is that the husband of the petitioner was working as Assistant Teacher in Vikas Khand Gariyaband and died on 15.10.99 while being in service vide death certificate Annexure P-1. The petitioner applied for the compassionate appointment on 15.11.99 vide annexure P-2. The application of the petitioner for compassionate appointment was forwarded to the Assistant Commissioner, Tribal Welfare vide Annexure P-3. Again vide letter dated 17.5.2000 (Annexure P-4) the case of the petitioner was forwarded and recommended by the Deputy Commissioner of the Tribal Welfare Department to the Joint Commissioner.</p> <p>Counsel for the petitioner submitted that the State Government of Chhattisgarh has also formulated a policy for providing the compassionate appointment vide Annexure P-5.
