Shri Prashant Jaiswal learned counsel for the petitioner. Shri Ranbir Singh learned GA takes notice for respondents.

Heard both the counsel.

The petitioner has preferred this petition under Articles 226/227 of the Constitution of India seeking a direction to the respondents for providing the compassionate appointment to the petitioner.

Case of the petitioner in brief is that the husband of the petitioner was working as Assistant Teacher in Vikas Khand Gariyaband and died on 15.10.99 while with in service vide death certificate Annexure P-1. The petitioner applied for the compassionate appointment on 15.11.99 vide annexure P-2. The application of the petitioner for compassionate appointment was forwarded to the Assistant Commissioner, Tribal Walfare vide Annexure P-3. Again vide letter dated 17.5.2000 (Annexure P-4) the case of the petitioner was forwarded and recommended by the Deputy Commissioner of the Tribal Welfare Department to the Joint Commissioner.

Counsel for the petitioner submitted that the State Government of Chhattisgarh has also formulated a policy for providing the compassionate appointment vide Annexure P-5. He further submitted that in spite of the recommendations of the Block Education Officer

Having heard the counsel for the parties and considered the facts and circumstances of the case, I am of the opinion that it will be appropriate to direct the petitioner to make a detailed representation to the respondent No.1 for compassionate appointment within thirty days from today. On receipt of the representation filed by the petitioner the respondent shall consider the same in view of the newly issued guidelines of the State of Chhattisgarh and pass appropriate speaking order with regard to the request of the petitioner for compassionate appointment.

Ordered accordingly.

The Writ petition stands disposed of.
