Dayal, Counsel for the Petitioner.</p> <p>Heard.</p> <p>The grievance of the petitioner is that he is a low paid employee of respondent no.2 drawing salary of Rs.2050/- and the administrator appointed by Gram Sewa Samiti has passed the order dated 19.4.2003 (Annexure P-1) transferring the petitioner from Raipur to Shahdol(M.P).</p> <p>The petitioner submitted representation on 23.4.2003 and without deciding the said representation, he rushed to this Court by filing this petition on 26.4.2003. In fact no time has been given to settle the said representation.</p> <p>Having considered the facts and circumstances of the case and material on record, in the opinion of this Court, ends of justice will serve if a direction is given to the petitioner to make a detailed representation along-with a copy of this order to the competent authority within fifteen days from today and on such representation being filed the competent authority shall decide the same by passing a reasoned order in accordance with law within <u>one</u> month from the date of production of representation. If any adverse order is passed and the petitioner thereby feels aggrieved, he may file the petition afresh challenging the said order. It is made clear that this Court has not expressed any opinion on the merits of the case.</p> <p>With the aforesaid observations, this petition stands disposed of.</p> <p>Consequently, M.W.P. and I.A., if any, stand disposed of.</p>
