The petitioner has completed his Class X Education in Government Higher Secondary School, Patthalgaon from where he filled up his examination form for the High School Certificate Examination conducted by the M.P. On this, the petitioner has submitted various representations; ^{h. marked} copies of the same are made as Annexure P/5, but no one was there to hear the grievance of the petitioner.</p> <p>Being harassed by the respondent/Board by not making correction of the date of birth in the mark sheet and because of inaction of the respondents, the petitioner has approached this Court and seeks a direction to the respondents that they shall carry out the correction as mentioned above.</p>
