ORAL JUDGMENT (PER F.I. REBELLO, J.)

The Petitioners by the present Petition have challenged Recruitment Rules framed under Article 309 of the Constitution of India for recruitment to the posts of Police Sub-Inspectors in the State of Goa. It was their contention that reserving posts based purely on sexual identification would be violating the concept of

equality under Article 14 and 16 of the Constitution of India. Petitioners have, therefore, sought to strike down the Rules on that count.

- further Notifications were issued by the Government thereby reserving 50 per cent of the posts. Now a further Affidavit has been filed dated 25th June, 2003 by Shri Muktesh Chander. In that it is set out that the letter dated 7-10-2002 whereby 50 per cent of Police Constables/Police Sub-Inspectors were reserved for male and remaining 50 percent were to be filled without reservation for male and female has since been withdrawn vide letter No.1/50/2001-HD(G) dated 24-6-2003.
- 3. It is further set out that hereafter all the vacancies of Police Constables/Police Sub-Inspectors would be filled in from amongst the male and female candidates without any reservation.
- 4. The statement made in the Affidavit on behalf of the Respondents by Muktesh Chander is accepted. Once that be the case, the Petition can be disposed, based on what is set out in the Affidavit.
