Petition under Section 437 & 439 of Cr. P.C. praying the High Court to release the petitioner on bail pending investigation , enquiry and trial in crime No. 106/2003 of Vemulavada Police Station, Karimnagar District.

The Court made the following :

ORDER :

-
“This is an application for bail by A3 and A4 in crime No. 106/2003 of Vemulawada P.S. Registered under Section 302 r/w 34 IPC and 109 IPC.

Since the allegation against the petitioners is that they instigated commission of the murder of the deceased and that fact is said to have been revealed by one of the accused in the offence after his arrest, and since petitioners are in custody for more than six weeks and since the investigation is almost completed, petitioners can be granted bail on some terms and conditions.

Petitioners /A3 and A4 shall be enlarged on bail on their executing a bond for Rs.10,000/- (Rupees ten thousand only) each with two sureties each in a like sum each to the satisfaction of the Judicial Magistrate of First Class, Sirsilla. Petitioners should not enter into Merupaka village and should not tamper with the evidence and should report their presence before the Station House Officer, Vemulawada police Station on every day between 9.00 A.M. and 10.00 A.M. till further orders of this court. ”
