Petition filed under Section 438 of Crl. P. C. praying that the High Court may be pleased to direct the S.H.O., L.B. Nagar Police Station , R.R. District , to release the Petitioner on bail in the event of his arrest in connection with Cr. No. 624/03 of L.B. Nagar, P.S., R.R. District

The Court made the following:

ORDER:

This is an application for Anticipatory bail by A-4 in Crime No. 624 of 2003 of L.B. Nagar Police Station, R.R. District, registered under Sections 468, 471 and 420 IPC.

Since the Petitioner is said to be a purchaser of the vehicle in auction and is plying the vehicle after obtaining permission and no objection certificate from the concerned authorities and since the other accused similarly situated like him are granted anticipatory bail, the petitioner also can be granted anticipatory bail. In the event of the Petitioner being arrested in connection with Crime No. 624 of 2003 of L.B. Nagar Police Station, R.R. District, he shall be enlarged on bail on his executing a bond for Rs. 10,000/- (Rupees ten Thousand only) with two sureties in a like sum each to the satisfaction of Station House Officer, L.B. Nagar P.S., R.R. District. The Petitioner should surrender before the Station House Officer, L.B. Nagar Police Station, R.R. District within ten (10) days from today and make himself available for interrogation as and when required by Police in Connection with the aforesaid crime and should also report his presence before the S.H.O., L.B. Nagar P.S. once in two days between 10.00 am and 11.00am for a period of Six (6) weeks after his release.
