Petition under Section 482 of Cr. P.C. praying the High Court to direct the S.H.O. Kurnool II Town P.S. to release the petitioner on bail in the event of his arrest by the respondent-police in connection with Cr.No. 39/2002 of Kurnool II Town Police Station.

The Court made the following :

ORDER :

-

“This is an anticipatory bail application filed by petitioner/ accused (A22) in crime No. 39 of 2002 of II Town P.S. Kurnool registered under Section 420 I.P.C. and Section 5 of A.P. Protection of Depositor's and Financial Establishment Act of 1999.

Since it is the contention of the petitioner that he is only an agent on behalf of the company which collected the deposits and that he deposited the amounts collected from the subscribers with the company in which he is working and since it is also stated that A18 and A19 in the crime, who are agents of the company, were granted anticipatory bail by this court earlier, the petitioner who is similarly situate like A18 and A19 were granted bail sought on the some terms and conditions on which A18 and A19 were granted anticipatory bail.

The petitioner/ A22 shall surrender before the Station House Officer, II Town P.S.Kurnool in crime No. 39/02 within one week from today. On such surrender he shall be enlarged on bail on his furnishing a personal bond for Rs.5000/- (Rupees five thousand only) with two sureties for a like sum each to the satisfaction of the SHO II Town P.S. Kurnool. The petitioner shall make himself available as and when required by the police for interrogation in connection with the said crime. ”
