The Court made the following :

ORDER :

“This is an application for bail by A 13 IN PRC.NO. 87 OF 2003 on the file of the JFCM, Metpalli Karimnagar District arising out of Crime No.71 of 2000, of Medipalli P.S. of Karimnagar District registered under Sections 148,302 read with section 149 of the Indian Penal code and under Section 27 of Indian Arms Act.

Since, the specific overt acts attributed to the petitioner, he can be granted bail on some terms and conditions.

The petitioner shall be enlarged on bail on his executing a bond for Rs.15,000/- (Rupees fifteen thousand only) with two sureties in a like sum each to the satisfaction of the Judicial First Class Magistrate, Metpalli, Karimnagar District subject to the condition that he should report his presence before the Station House Officer, Medipalli Police Station on every Sunday between 9.00 A.M. and 10 A.M. till the case is committed to the court of Sessions.”
