The learned Claims Tribunal directed to release Rs.10,000/- only towards maintenance and studies of her children. Aggrieved therewith, the applicant is before this Court.</p> <p>Having considered the facts and circumstances of the case and material on record, let the claimants be allowed to withdraw Rs.15000/- more in addition to Rs.10,000/- as directed by the Tribunal.</p> <p>Learned counsel for the applicant stated that he is satisfied at the Bar.
