Learned counsel for the petitioner submitted that the petitioner is a victim of frequent transfers. It is submitted that within 3 three years as many as six transfers have been effected. It is further submitted that now the petitioner who was working as Range Officer, Flying Squad, Raipur has been transferred to Belgehana Marwahi Forest Division as Forest Ranger, vide order dated 13.2.2004 which is under challenge in this petition and the name of the petitioner has been shown at Sl.No.12 in the impugned order. It is also submitted that the petitioner made the representation vide amexure P/7 to the Conservator of Forests, Raipur, which has not yet been decided.

Having considered the facts and circumstances of the case and material on record, ends of justice will be served if a direction is given to the petitioner to make a detailed representation afresh to the Competent Authority/ respondents No.2 &3 alongwith a copy of this order and petition within seven days and on such representation being filed, the Competent Authority/respondents No.2 & 3 shall consider and decide the case as early as possible preferably within a month thereafter.
