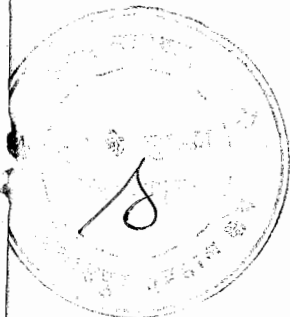

He prays that in similar matter bearing W.P.(S) No. 2072/2004, orders have been passed by the High Court of Madhya Pradesh on 13-4-2004. Counsel prays for similar order in this case also.</p> <p>Counsel for the respondents submitted that relying on the statement of the counsel for the petitioners made at the Bar, similar orders may be passed.</p> <p>Having thus considered and relying on the statement made by counsel for the petitioners at the Bar, it is directed that the representation filed by the petitioners shall be decided within a period of three months from the date of receipt/production of this order.
