Learned counsel for the petitioner submits that the matter relates to transfer of the petitioner. He further submits that the petitioner is in Education Department and the transfer has been effected by the Trial Department. He also submits that inspite of time being taken, return has not been filed by the State counsel. He also submits that for the present the petitioner may be given an opportunity of filing the detailed representation before the competent authority of the respondents, which shall be considered on its own merits in accordance with law.

Having considered and without expressing any opinion on the merits of the case, in the opinion of this Court, ends of justice will be served if a direction is given to the petitioner to make a detailed representation raising his grievances before the competent authority of the respondents alongwith a copy of the petition and this order, wthin 10 days, and on such representation being filed, before the competent authority of the respondents shall decide the same on its own merits in accordance with law by a reasoned order as erarly as possible
