Ramesh Kumar, S/o Sitaram Rawat, has filed this appeal under Section 374(2) of the Cr.P.C. against the judgement dated 5.12.2003 passed by the Special Court, (ST, SC) Act, Jagoalpur (Bastar) in S.T.No. 451/2003 and convicted him for the offence punishable under Section 376(1) of the IPC and sentenced to undergo RI for seven years, further convicted under Section 3(1)(12) of Scheduled caste and Scheduled Tribe (Prevention of Atrocities) Act and sentenced to undergo RI for three years and pay a fine of Rs. 3000/- on each count.

This appeal was filed through legal aid on 21.1.2004 and was admitted on 4.2.2004. Thereafter, Shri Pravin Das Advocate submitted that the father of the appellant has engaged him to file an appeal on behalf of the appellant and he filed the Cr.A.No. 42/2004 on 12. 2004. That appeal was also admitted on 15.1.2004.

Since Cr.A.No. 42/2004 filed by the appellant through the counsel has been admitted by this Court and the same is pending. I am of the opinion that this appeal Cr.A.No. 74/2004 filed through legal aid has to be disposed of as unnecessary. Accordingly, Cr.A.No. 74/2004 is disposed as unnecessary.
