After hearing the learned Counsel, I am of the view that it is unnecessary for me to express any opinion on the merits of the matter in the light of the pending representation in Annexure 'D'. terms of In the given circumstances, I deem it proper to direct the respondents to consider Annexure 'D' on merits and in accordance with law including the applicability of the Judgment of this Court in W.P.Nos.13858-67/2000 dated 31.03.2003 or other Judgment rendered subsequently and pass orders within twelve weeks from the date of receipt of a copy of this order. No opinion is expressed on the merits of the matter.
