Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein, the High Court will be pleased to issue a writ, order or direction particularly one in the nature of writ of mandamus declaring the action of the respondents in forcibly taking away the petitioners' lands of an extent of 50 Ft width from the existing road boundary for road widening on the National Highway No.9 and laying of pipeline in the said land in Sy.Nos. 731, 733, 736, 737 and 738 situated at Pedakaparthi Village, Chityal Mandal, Nalgonda District as totally illegal and without jurisdiction and also violative of proviso to the article 31A(1) and Article 300-A of the Constitution of India and consequently direct the respondents not to interfere with the possession and enjoyment of the lands by the petitioners in Sy.Nos. 731, 733, 736, 737 and 738 situated at Pedakaparthi Village, Chityal Mandal, Nalgonda District except through due process of law.

The Petition coming on for hearing upon perusing the petition and affidavit filed herein and upon hearing the arguments of Mr. S.Lakshma Reddy, Advocate for the Petitioners and of the Asst. G.P. for Roads & Buildings, on behalf of the Respondents 1 to 3 & 5 and of G.P. for Panchayat Raj, on behalf of the Respondent No.4.

The Court made the following **ORDER**:
