Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein the High Court will be pleased to pass an order or a direction or a writ more particularly one in the nature of Mandamus directing the respondents herein to allot the petitioner herein any house site any where near the proposed International Airport at Shamshabad and to dispose of petitioner's pending application addressed to the third respondent herein and pass.

The Court made the following :

ORAL ORDER :

-

Under Section 4(1) Notification of the Land Acquisition Act, the petitioner's house site was acquired by the Government for the purpose of establishing an International Air Port at Samshabad. The petitioner filed an application that in lieu of compensation he maybe allotted alternative house site for constructing a house.

The only submission made by the learned Government Pleader is that the respondents' authorities have to consider the claim of the petitioner in the light of the scheme if any prepared for the allotment of alternative land.

In view of the same, the respondents shall consider and pass appropriate orders on the representation made by the petitioner if there is any scheme under which the petitioner is entitled to have alternative land. If there is no such scheme formulated, it is needless to add that the petitioner is entitled to receive compensation for the deprivation of his house site under the provisions of Land Acquisition Act.

With the above observations, the writ petition is disposed of accordingly. No costs.
