Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein, the High Court will be pleased to issue a writ order or direction more particularly one in the nature of Writ of MANDAMUS, declaring the action of the 1<sup>st</sup> respondent through his proceedings dated: 28-10-2003 in RC.NO. 3222/2002 P and the consequential proceedings of the 2<sup>nd</sup> respondent dated. 29-10-2003 in RC.NO. 3222/2003 CSR(O) as illegal, arbitrary, unconstitutional, without any power or authority or jurisdiction consequently set aside the same.

The Petition coming on for hearing upon perusing the petition and affidavit filed herein and upon hearing the arguments of Mr. T.Rajendra Prasad, Advocate for the Petitioners and of G.P. for Co-operation, on behalf of the Respondent No.1.

The Court while observing from the material placed before this court, it appears that the first respondent gave a communication to the Second respondent by his letter dated. 28-10-2003, directing the Second respondent to cancel the plots allotted to the staff and workers of the society as well as for temple/church/mosque.

In terms of the said letter, the second respondent, passed the order canceling the allotment of the plots. But, the said letter issued by the first respondent does not contain any reasons or material on which such a direction was issued. Therefore, the first respondent is directed to place before this court, the material basing on which the said letter dated 28-10-2003 was issued. The said direction is to be complied with, within a period of ten days from today.

So, for the same the first respondent is directed to appear before this court on 29-03-2004 at 10.30 A.M. alongwith the material.
