Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein, the High Court will be pleased to issue an order or writ one in the nature of Writ of Mandamus declaring the action of the respondents in constructing any Bund or Katta Pydipalem Village Simhadripuram Mandal, Cuddapah District. In our lands in Sy.No. 168/1to8, 169/7 to 12 the neighbouring lands in the surrounding Sy.No. 284, 285, 289 or Sy.No. obstructing the flow of water from own lands as arbitrary illegal, unconstitutional violative of principles of natural justices and consequently call for the records and quash dry proceeding issued to the third respondent for construction of any Bund or Katta in the Kunta lands.

The Petition coming on for hearing upon perusing the petition and affidavit filed herein and upon hearing the arguments of Smt. N.Shoba, Advocate for the Petitioners and of the G.P. for Panchayat Raj for Respondents 1 and 2 and of Mr. P.Veera Reddy Advocate for the Respondent No.3.
