ORDER:

Heard the learned counsel for the petitioners and the learned Government Pleader for Revenue and with their consent the writ petition itself is disposed of at the stage of admission.

The petitioners seek to challenge the proceedings No.B/61/97, dated 03-11-2004 issued by the third respondent-Mandal Revenue Officer ordering resumption of the Government lands assigned to the petitioner Nos.1, 3, 4, 5 and father of 2nd petitioner in Survey No.1576 admeasuring Ac.5-00 and in Survey No.1619 to an extent of Ac.8-25 cents situated at Chowtakur village, Pulkal Mandal of Medak District, on the ground of violation of assignment conditions, as illegal and arbitrary.

The learned Government Pleader for Revenue appearing on behalf of the respondents submits that there is an alternative remedy of appeal available to the petitioners before the Joint Collector against the impugned order passed by the third respondent-Mandal Revenue Officer and the petitioner without exhausting the appeal remedy, approached this Court invoking the jurisdiction under Article 226 of the Constitution of India.

Having regard to the fact that the petitioners have alternative remedy by way of appeal before the Joint Collector, it is open to them to avail the alternative remedy of appeal before the Joint Collector within four weeks from today. Till such time, status quo existing as on today shall be maintained.

The writ petition is disposed of accordingly at the stage of admission.
