

In the light of the view taken by me in CM(M) 8/2004 and other connected matters that there are concurrent findings of the two courts below and further that the petitioners were allotted the premises by virtue of being in the employment of respondent company and since they have ceased to be in the employment of the company as some of them have retired, some have resigned while some have taken voluntary retirement and some of them have expired and therefore they are no more entitled to retain the possession of the premises and further that dispute as to the title of the premises, if any, is between the DDA and respondent company and the petitioners have no locus standi to challenge the ownership of the respondent it as they were given possession of the premises purely by virtue of being the employees of the respondent company and further that eviction proceedings cannot be allowed to be converted into title suit, these petitions have no merit and are hereby dismissed.

However, looking to the hardship the petitioners may face in shifting to some other place, they are given six months time to vacate the premises whereafter respondent shall be entitled to seek execution of eviction decree.

Interim order, if any, stands vacated.
