Learned counsel for the petitioner submits that the petitioner who is presently working on the post of Treasury Officer in District Treasury, Ambikapur, has been transferred from Ambikapur to District Panchayat, Jashpur. He submits that this transfer is contrary to the transfer policy and the transfer has been effected in the ban period. He further submits that according to the policy, the transfer should be effected after completion of more than three years at a place and the petitioner has not completed three years at Ambikapur. He also submits that the home district of the petitioner is Jashpur and he should not have been transferred at his home district-Jashpur.

For the present, learned counsel for the petitioner submits that this petition may be permitted to be withdrawn with a liberty to the petitioner to file a detailed representation before the concerned authority and the concerned authority may be directed to dispose of his representation within the stipulated period granted by this Court.
