Learned counsel for the petitioner submits that the petitioner who is presently working as Upper Division Teacher in Government Middle School, Phirangipara, Kota, District Bilaspur has been transferred to Government Middle School, Mohli Kota, District Bilaspur vide impugned order dated 31.8.2005 (Annexure P-1). He submits that wife of the petitioner is posted at Government Middle School, Gobaripat, Kota which is at a distance of 15 kms from Phirangipara, whereas it will be about 40 kms from Kota. He also submits that the transfer is effected violating the transfer policy framed by the State Government. He further submits that wife of the petitioner remains in ill condition, therefore, transfer to a distant place is material in this case.

Learned counsel for the petitioner submits that for the present this petition may be disposed of with a liberty to the
