As per order dated 03.06.2005 (Annexure P-1) the petitioner has to join his parent department i.e. Police Department. The petitioner is seeking stay of the order dated 03.06.2005 (Annexure P-1) whereby he was to go back to his parent department by 26.06.2005. During this period, the petitioner met with an accident. He suffered from Compound Fracture Autabulum Left and he requires hip replacement surgery immediately. The best hospital for the purpose is situated in Bilaspur. The petitioner has already made a representation on 21.04.2005 to the authorities.</p> <p>In view of the facts that the petitioner needs hip replacement surgery and he is not in a position to perform normal police duty, the authorities are directed to consider the representation of the petitioner made on 21.04.2005, sympathetically, within a period of one month from the date of receipt of this order.</p> <p>With the above direction, the petition stands disposed of.</p> | |
