ORDER:

This writ petition is filed questioning the order dated 07-04-2005 passed under the Andhra Pradesh Assigned Lands (Prohibition of Transfer) Act, 1977 (hereinafter referred to as 'the Act') thereby resuming the land in possession of the petitioner.

Though the learned counsel for the petitioner raised various contentions, I am not inclined to express any opinion since against the impugned order dated 07-04-2005 an efficacious alternative remedy of appeal is available under the Act.

The writ petition is accordingly disposed of granting leave and liberty to the petitioner to workout the alternative remedy. However,

having regard to the facts and circumstances of the case, there shall be a direction that status quo obtaining as on today as to the nature and possession of the land-in-question shall be maintained for a period of four weeks from today. No costs.
