This writ petition is filed to declare the action of respondents in not sanctioning family pension, gratuity, provident fund and other retirement benefits along with arrears of Late Bangaraiah Setty, to the petitioner, as arbitrary and illegal.

Heard learned counsel for the petitioner and learned counsel appearing for the respondents.

Whether the petitioner is entitled for the pension, gratuity, provident fund and other retirement benefits of her husband, has to be decided by the respondents in accordance with law.

Therefore, without entering into the merits of the case, the writ petition is disposed of, with a direction to the respondents to take appropriate decision in pursuance of the representation made by the petitioner dated 18-09-2004, if it is pending with them, within a period of four months from the date of receipt of a copy of this order.

The writ petition is accordingly disposed of. There shall be no order as to costs.
