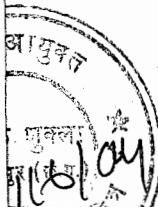

ORDER

(Passed on 30th November, 2006)

1. Learned counsel appearing for the respondents/State submits that the Collector, Raigarh has submitted the scheme for rehabilitation of the employees of liquidated respondent 5 Bank.
2. The State Government in exercise of its power under Section 55(1) of Chhattisgarh Cooperative Societies Act, 1960 has framed rules namely, Liquidated Cooperative Bank Employees Rehabilitation Rules, 2006, for the purpose of rehabilitation of the employees of the liquidated banks.

In the back ground of the case, it is necessary that the Registrar, Cooperative Societies Chhattisgarh, Raipur should provide an opportunity of hearing to the representatives of the Petitioners Sangh and take place for their rehabilitation in accordance with Liquidated Cooperative Bank Employees Rehabilitation Rules, 2006 and also as per the rehabilitation scheme submitted by the Collector, Raigarh. The Registrar, Cooperative Societies Chhattisgarh, Raipur will consider the cases of those employees also who have attained the age of superannuation during pendency of this petition, within a period of three months from the date of receipt of representation, if any. The petitioner is at liberty to make detailed representation to the Registrar, Cooperative Societies Chhattisgarh, Raipur, if so advised

3. In view of the aforementioned direction, this writ petition stands disposed of. No order as to Costs.
