ORDER

The following order of the Court is passed by Satish K. Agnihotri, J.

1. Learned counsel appearing for the petitioners as well as for the State/respondents jointly submit that the facts of the present writ petition are similar to that of in W. P. (S) No. 5976/2006 (Sushil Tiwari and others vs. State Govt. of Chhattisgarh & others), which was allowed vide order dated 7.11.2006. They further submit that the question of law involved is also the same.
