	<p><b>23-1-2006</b></p> <p>Shri Rakesh Pandey, counsel for the petitioner. Shri S. S. Rajput, Dy. Govt. Advocate for the State. Heard.</p> <p>Counsel or the petitioner submits that by the impugned order dated 7-1-2006, the petitioner has been transferred from Tehsil Charama to Dantewara on administrative. He further submits that it is a mid session transfer during ban period. He further submits that for the present the petitioner may be given an opportunity of filing the detailed representation before the competent authority of the respondents, which shall be considered on its own merits in accordance with law.</p> <p>Prayer is not opposed by the State counsel.</p> <p>Having considered and without expressing any opinion on the merits of the case, in the opinion of this Court, ends of justice will be served if a direction is given to the petitioner to make a detailed representation raising his grievances before the competent authority of the respondents along with a copy of the petition, within 10 days from today, and on such representation being filed, the competent authority of the respondents shall decide the same on its own merits in accordance with law as early as possible preferably within six weeks from the date of receipt of the representation.</p> <p>Learned counsel or the petitioner submits that the petitioner has not been relieved and he may be allowed to continue.</p> <p>It is directed that if the petitioner has not been relieved, he may be allowed to continue till the representation is decided.</p> <p>With the aforesaid observations, this petition stands disposed of.
